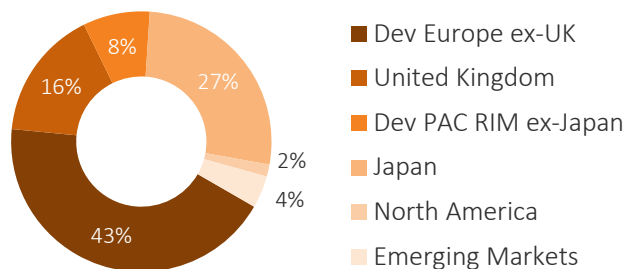


OVERVIEW

The SGA International Equity Fund (the “International Equity Fund” or the “Fund”) seeks total return, consisting of current income and long-term capital appreciation, by investing principally in non-U.S. equity securities and other permitted vehicles representing generally mid- to large-sized businesses whose headquarters or majority of economic activity are or were at one time outside the United States.

INVESTMENT PROCESS

SGA’s investment process can best be described as a combination of both systematic and traditional approaches to sound fundamental research. SGA believes a disciplined fundamental approach that integrates proprietary systematic and traditional analysis applied globally will generate superior risk-adjusted returns.
